# For what purpose do we process your personal data?

Your personal data is necessary for the execution of a contract concluded with you as our client, in connection with the conclusion of a sales contract for a commercial good or service purchased in Mebel Art, and in the period of Mebel Art's responsibility as part of warranty and guarantee for the purchased commercial goods.

## What data do we need to conclude and perform the contract?

We must have your personal data, such as: name and surname, ID no. (VAT), address of residence, correspondence address, if different from the address of residence, address of the place of performance, telephone number and e-mail address.

## Is it necessary to consent to the processing of your personal data?

Yes. If you do not agree with this, we will not be able to process your order and conclude a contract. Please remember that consent to the processing of your personal data can always be withdrawn. We will process your personal data until you withdraw your consent or until the end of the contract, after the period of warranty and guarantee. Mebel Art processes only personal data that is necessary for the conclusion and performance of the contract.

#### What rights do you have in relation to the processing of your personal data?

You have the right to access, rectify, erasure, restrict, portability, objection and withdraw your consent to the processing of personal data.

Any person whose data is processed may exercise the right to withdraw consent to the processing of personal data if: he or she notices that the data provided is incorrect or incomplete, the collected data will no longer be necessary for the purposes for which it was collected and will be processed incorrectly with the law. You have the right to lodge a complaint regarding processing of your personal data by Mebel Art to the supervisory authority, which is the Inspector General for Personal Data Protection, ul. Stawki 2, 00-193 Warsaw, Poland. The right to withdraw consent to the processing of personal data may be used from 25 May 2018.

# How long and for what purpose do we collect your personal data?

We collect personal data during term of the contract concluded with you and after its completion, during the warranty period, in order to: claim for the performance of the contract, fulfill obligations under the law, in particular tax and accounting, and resulting from warranty and guarantee as well as archiving. Your personal data will be kept by Mebel Art for 6 years from the date of contract performance.

#### Who can we transfer your personal data to?

Your personal data, Mebel Art, can only transferred to a subcontractor who will carry out the contract at the request of Mebel Art. Mebel Art may entrust your personal data only on the basis of a contract with the subcontractor to entrust the processing of personal data. Mebel Art as a data controller is responsible for who the personal data will be entrusted to and for the supervision of compliance by the subcontractor the principles of GDRP.
